### License Agreement for Use of Collected Transients Sound Effects Libraries

By acquiring Collected Transients Sound Effects Libraries, you agree to be bound by the terms and conditions of this license agreement. These license terms apply to any and all Collected Transients Libraries.

### Definitions

**These terms will be used throughout the EULA and are defined below.**

- **"Library"** or **"Libraries"** means Collected Transients Sound Effects Libraries, including all sounds, documentation, and other materials contained therein.
- **"Sounds"** means the individual sound effects files included in the *Libraries*.
- **"Licensor"** means Collected Transients.
- **"Licensee"** or **"you"** means the individual or entity acquiring a license to use the *Libraries*.
- **"Project"** means any film, video, television, game, internet, radio, or other media production that the Licensee is providing services to for commercial or non-commercial purposes.
- **"Workstation"** means a single computer or similar device used by the *Licensee* for the purpose of working on *Projects*.

### **1. Grant of License**

Collected Transients *Libraries* are licensed, not sold. Acquisition of *Libraries* from *Licensor*, whether purchased or provided free of charge, grants *Licensee* a nonexclusive, royalty free, perpetual license to use the *Libraries* that you received from Collected Transients within all of the terms set out in this license agreement.

### **2. Rights Granted**

The license granted in this agreement permits *you* and only *you* to:

- Use *Libraries* on **one workstation** each at a time.
- Create backup copies of *Libraries* on other storage devices.
- Synchronise the *Sounds* in any number of *Projects*
- Reproduce the *Sounds* for the purpose of those *Projects*.
- Publicly perform the *Sounds* in respect of those *Projects*.

### **3. Restrictions on Uses**

The license granted in this agreement is solely for the *licensee* and limited to *licensee's Projects*. It does not permit *licensee* to:



- Use, reproduce, adapt, modify, repackage, sell, or license any *Library* or *Sounds* other than in respect of a *Project*. (You may not act as a distributor of the *Libraries* or *Sounds* yourself.)
- Distribute or perform reproductions of the *Sounds* where *Sounds* are not incorporated in and synchronized with at least one additional media element (music, voice, film, video, etc.). This restriction applies to but is not limited to ringtones, applications such as soundboards, toys, greeting cards, and hardware devices.
- Use *Sounds* or *Library* in the creation of another sound effects library, sample library, or any other kind of library for distribution.
- Use *Sounds* or *Libraries* in any way for any kind of Machine Learning, Large Language Models, Generative Artificial intelligence, or similar AI systems, whether for commercial or non-commercial purposes.

#### **4. Copyright**

Copyright of the *Sounds* and *Libraries* is owned by *Licensor* and other than the license rights granted in this agreement all rights in the *Sounds* and *Libraries* remain the property of *Licensor*.

#### **5. Assignment**

*Licensee* may not assign the *Library* or *Sounds* to any other party.

#### **6. Termination**

The license granted under this agreement, and the *licensee's* right to use the acquired *Libraries* will automatically terminate in the event of any breach by you of the terms of this agreement and you will be required to destroy all copies of the *Libraries* you have produced. *Licensee* will be notified in writing upon Termination of the license.

#### **7. Indemnity**

*Licensee* will indemnify *Licensor* from, and against any and all claims, demands, suits, damages, liabilities and all reasonable expenses, including legal fees incurred by *Licensor* with respect to any matter that arises as a result of a breach of this agreement by you.

#### **8. Jurisdiction**

This agreement is governed by the laws of the state of Illinois, without regard to its conflicts of law principles.

#### **9. Entire Agreement**

This EULA is the complete and final agreement between the *Licensor* and *Licensee* regarding the *Libraries*.
